

SIZE RANGE

Our standard tubing range consists of metric & imperial sizes. We can also accommodate other sizes to suit individual requirements from a minimum ID of 0.6mm to a maximum OD of 25mm.

PTFE tube is supplied in natural as standard, other colours from our full range are available on request.

PACKAGING

PTFE tube is supplied as random lengths in coils or on reels as appropriate. Cut lengths are available along with other services such as flaring and tafting.
